PART C3: SCOPE OF WORK

C3.1 MANDATE

The Automotive Industry Development Centre (AIDC) serves to develop the automotive manufacturing sector to globally competitive standards of excellence, through a world-class value proposition which enables effective and sustainable socio-economic growth. The organization was established as a government support centre, to increase the local automotive industry's global competitiveness and to promote Gauteng as the automotive industry investment destination of choice.

The organization is the dedicated developmental agency of the Gauteng Growth and Development Agency (GGDA) in relation to the specific industrial, infrastructure and training needs required by the automotive and allied sector - in particular those based in the Gauteng province.

The AIDC is thus tasked by GGDA with special developmental-oriented projects aimed at retaining and attracting investments in the automotive and allied-related sector with a focus on enterprise development; support BBEE SMME development, skills development and limited logistical infrastructure in line with the Gauteng provincial government's objectives of transformation, modernization and re-industrialization (TMR). The AIDC also undertakes projects related to the transport and energy sectors, as well as the development of the Auto City in the Northern Corridor.

C3.2 BACKGROUND TO THE TENDER

C3.2.1 INTRODUCTION

The Supplier Park Development Company SOC Ltd trading as AIDC (hereinafter referred to as "AIDC") is a state-owned company (SOC) with all its shares held by the Gauteng Growth and Development Agency (GGDA), an agency of the Department of Economic Development of the Gauteng Province. The company was established to primarily provide support to the SA Automotive and Allied Industry, in its drive for global competitiveness.

AIDC, an entity of the Gauteng provincial government developed Buildings/ mini factories to accommodate tenants that may require manufacturing space for their operation within the Automotive Supplier Park. The Automotive Supplier Park (ASP) hosts different types of tenants ranging from manufacturing to logistics.

It remains AIDC's (Facilities Maintenance Management) core function to ensure that the facilities occupied by the tenants and service providers are safe and sound to be occupied, fully operational to ensure that they comply with the SANS 10400 regulation.

The aim of the tender is to request interested and experienced contractor for As and When Plumbing Works for the Period of 36 Months at The Supplier Park Development Company Soc Ltd T/A AIDC within The Automotive Supplier Park Site (Rosslyn, Pretoria) and its remote sites.in Pretoria.

Emphasis will be placed on quality of experience and expertise of the appointed Contractor Team, the extent that the team can provide the integrated knowledge and expertise required to facilitate decision-making processes and the proposed methodology, as well as Insight and understanding into the general As and When Plumbing Works.

The supply & installations shall comply with the following regulations:

- a) SANS 10400: The application of the National Building Regulations.
- b) SANS 10142: The application of the Safe Installation of PLUMBING Wiring In South Africa.
- c) SANS 1200: The application of the Civil Engineering In South Africa.
- d) SABS 0400 other applicable Code of Practices
- e) SABS Standards
- f) The Occupational Health and Safety Act, Act No. 85 of 1993
- g) Applicable Local Municipal By-Laws and Regulations
- h) Issue applicable Certificate of Compliances (COC) where necessary

C3.4 TENDER SCOPE

This request will cover all as-and-when PLUMBING works requirements which cannot be efficiently delivered internally due to the magnitude and urgency of requests. Additionally, this will include requests for onboarding of tenants, rectification of existing crucial maintenance emanating from backlog built up over the accumulative years.

As per the Occupational Health and Safety Act, 1993 requirement, that a safe working environment without risks to the health of occupants of buildings should be reasonably always maintained. Thus, facilities provided to AIDC tenants should always be in a safe, leak-free condition, acceptable and habitable state etc.

The AIDC is therefore required to promptly address/ close the gaps impeding the respective daily operation of tenants by improving their facilities and surroundings to acceptable standards and to sustain the usefulness and value of AIDC properties.

C3.4.1 SCOPE OF WORK – OVERVIEW

The appointed maintenance contractor shall provide, as a minimum, the below services:

- 1) The maintenance contractor shall thoroughly inspect the plumbing infrastructure in accordance with the provisions outlined in the Occupational Health and Safety Act at appropriate intervals.
- 2) Carrying out plumbing maintenance works to enable all facilities to operate in accordance with original design specifications.
- 3) Ensuring all plumbing maintenance work is performed by competent, skilled and experienced persons as defined by the relevant regulations under the supervision of the contractor. The AIDC reserves the right to request copies of certificates and qualifications for technical personnel.
- 4) The provision of maintenance service twenty-four (24) hours a day, seven (7) days per week as and when required. The call-out service and associated costs shall be provided at the tendered rates. All personnel shall be provided with adequate tools of trade to ensure prevent delays to emergency callout response.
- 5) Repairs and maintenance to finishes obligated by wear and tear, preventative maintenance etc. and only parts that are suitable in all respects, shall be used.
- 6) The timeous repairs and replacement of obsolete items to reduce breakdowns, down time, unplanned maintenance and consequently maintain optimal plumbing infrastructure operation.
- 7) The provision of maintenance site registers, keeping accurate records of all maintenance activities, planned repairs and routine safety related operational tests for submission to the AIDC Facilities Manager.
- 8) The provision on request by AIDC facilities Manager computer generated reports detailing a history of callouts, repairs and break-down repairs.
- 9) To alert and advise the AIDC Facilities Manager in writing of any repairs and replacement required to existing infrastructure deemed necessary. No repairs or maintenance work shall be undertaken without permission form the AIDC Facilities Manager or AIDC duly appointed consultants.
- 10) The AIDC to exercise step in rights in case the appointed contractor fails to comply with repairs and maintenance obligations. The AIDC shall remedy the default either, itself or procure a third party (including any subcontractor or supplier of the appointed contractor) to do so on its behalf. The reasonable costs of the Employer exercising its step-in rights in respect of any subcontractor or supplier of the contractor shall be borne by the contractor.
- 11) The As-and-When plumbing work entails the installation, maintenance, repair or renovation, alterations. The plumbing maintenance service provider shall focus mainly but not limited to, the items as follows:
 - Alterations to existing plumbing infrastructure
 - Gutters and down pipes repairs & maintenance
 - All flushing roof repairs & maintenance
 - Industrial Water Pipe repairs & maintenance

- New installation and removal of equipment
- Minor and major demolitions in preparations for plumbing fittings
- Carry out planned maintenance and corrective maintenance
- Cleaning Sewer line & maintenance
- External restoration works, tarring, paving, etc.
- Water pipe repairs & maintenance
- Upgrade and modernizing key plumbing infrastructure
- Ablution facilities water network maintenance
- And other building plumbing related works
- Storm water, manholes and drainage goods maintenance
- Compliance with all applicable building codes
- The scope also includes a 24hr, Monday to Sunday emergency standby service as and when required by AIDC

13) CALL OUT RESPONSE - TIMES

The appointed contractor shall ensure at any time of the day or night, seven (7) days a week, inclusive of statutory holidays, for the duration of contract, that competent staff is available to timeously attend to call-outs including emergencies.

14) WORKMANSHIP

- The appointed contractor shall employ only competent personnel including artisans to perform plumbing maintenance work.
- The works shall be executed using the latest technology, trends and best practices in accordance with building regulations to the satisfaction of AIDC. All remedial work or poor workmanship shall be rectified at the cost of the contractor
- The appointed contractor shall remain responsible for completing maintenance of the plumbing infrastructure appropriately. The inspections by the AIDC department shall not discharge the contractor

15) QUALITY OF MATERIAL AND EQUIPMENT

- Only quality material suitable for the climatic conditions of relevant sites shall be utilized, subject to approval by AIDC Facilities Manager. All material and equipment shall satisfy the requirements of SABS or OEM in respect of quality, manufacture, tests, and performance.
- Materials manufactured within the Republic of South Africa and bearing the SABS approval shall be utilized where applicable. All materials shall be suitable for the conditions under which the materials are installed and used.

16) MONTHLY REPORTS

The appointed PLUMBING maintenance contractor shall ensure that all reports for the corresponding month are attached and corresponds with monthly invoices. The monthly reporting shall include but not limited to:

- Issued maintenance work job cards (including percentage splits between, completed scheduled, unscheduled, emergencies etc.)
- Signed off job cards between the contractor and AIDC tenant/ representative, reflecting relevant job card numbers
- Itemized format and summary for each invoice
- The summary of materials, labour, and percentage markup to be included on issued job cards.
- The appointed contractor shall keep records of all submitted reports for at least 3 years after expiry of contract.
- The final format for the maintenance reports shall be agreed between the contractor and the AIDC Facilities Manager from time to time.

C3.5 HEALTH AND SAFETY

The Contractor shall be required to comply with the Occupational Health and Safety Act, 1993: Construction Regulations, 2014 (the regulations) as promulgated in the applicable Government Gazette. Non-compliance with these regulations, in any way whatsoever, will be adequate reason for suspending the Works.

The Contractor shall in terms of regulation 5(1) provide a comprehensive health and safety plan detailing his proposed compliance with the regulations, for approval by the Employer.

The Contractor shall at all times be responsible for full compliance with the approved plan as well as the Construction Regulations and no extension of time will be considered for delays due to non-compliance with the abovementioned plan or regulations.

Payment items are included in the Schedule of Quantities to cover the Contractor's cost for compliance with the OHS Act and the abovementioned regulations.

COVID-19 Occupational Health and Safety Measures in Workplaces COVID-19 (C19OHS), 2020

The Contractor shall be required to comply with the COVID-19 Occupational Health and safety Measures in Workplaces act: COVID-19 (C19 OHS), 2020 for as long as the declaration of a national disaster published in Government Gazette 43096 on 15 March 2020 remain in force. Non-compliance with these regulations, in any way whatsoever, will be adequate reason for suspending the Works or termination of contract.

C3.6.2 PROTECTION OF THE PUBLIC

The site is accessible to the general public. The Contractor shall ensure that all personnel entering the construction site is fully informed about the dangers, dos and don'ts on the site. The Contractor shall ensure that non-construction personnel are protected within the guidelines of the OH&S Regulations.

C3.6.3 BARRICADES AND LIGHTING

All working space shall be securely barricaded at all times in accordance with the requirements of the applicable OH&S Regulations.

C3.6.4 TRAFFIC CONTROL ON ROADS

The Safety Officer shall take full responsibility for the traffic control in and around the site. The personnel on site shall be fully informed and trained by the Safety Officer regarding the construction traffic and general traffic control.

C3.6.5 MEASURES AGAINST DISEASE AND EPIDEMICS

Necessary measures must be adopted and implement occupational health and safety measures to reduce and eliminate the escalations of infections in workplaces against disease, epidemics and pandemics on site as and when directed by the Department of Labour.

C3.6.6 AIDS AWARENESS

All construction personnel shall be given an Aids Awareness briefing session by the Safety Officer.

C3.6.7 COVID-19 AWARENESS

All construction personnel shall be given an COVID-19 Awareness briefing session by the Safety Officer.

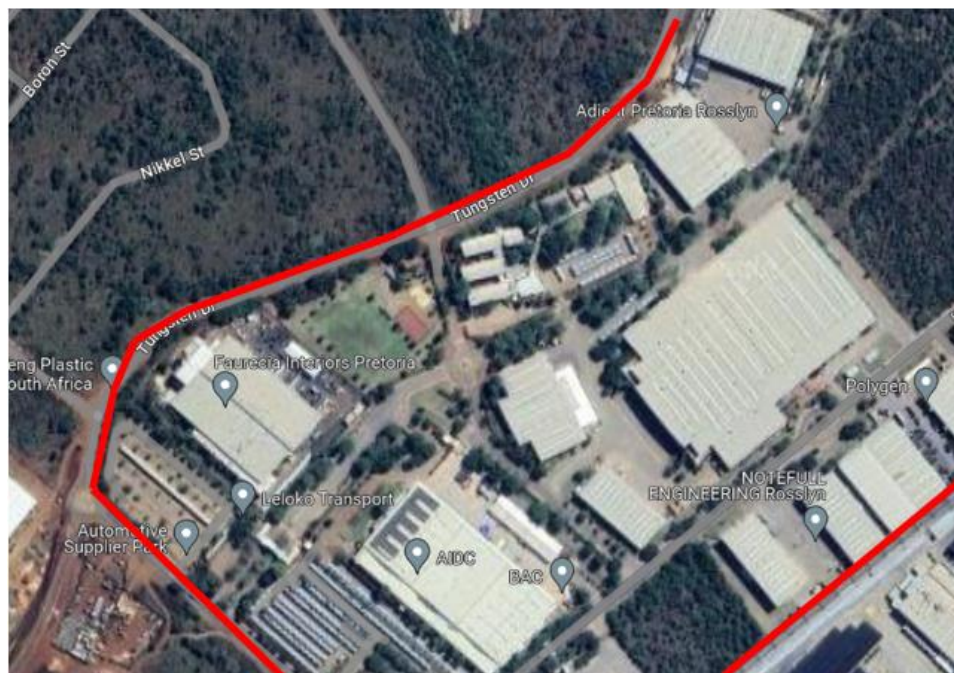
